

**FOR PUBLIC MEETINGS OF
THE FRANKLIN COUNTY CANVASSING BOARD
FOR THE NOVEMBER 8TH, 2016
GENERAL ELECTION**

PERSUANT TO Florida Statutes s102.14 (2) this notice shall serve as reasonable Public Notice for the canvassing of Mail Election Ballots. PERSUANT TO Florida Statutes Chap. 286 the Franklin County Canvassing Board is subject to the Sunshine Law. PERSUANT TO Florida Statutes, all meetings of the Franklin County Canvassing Board are open to the public and will be conducted for the November 8th, General Election at the Franklin County Supervisor of Elections Office located at, 47 Avenue F, Apalachicola, Florida.

The Franklin County Canvassing Board will meet at 10:00 AM on Friday, November 4th, to begin canvassing of Vote by Mail Ballots. FS s101.6103 (6) Board majority required. No results shall be available. The Canvassing Board will reconvene at 3:00 PM on Tuesday, November 8th, to continue canvassing of Vote by Mail Ballots. Board majority required. No results shall be available.

On Tuesday, November 8th, 2016, at 3:00 PM at the Supervisor of Elections Office, the Canvassing of Vote by Mail Ballots will continue until the close of the Election at 7:00 PM. Board majority required. Unofficial results of the Election will be available after 7:00 p.m. on November 8th, 2016. At this time, the Board will make a random selection of a precinct and contest for the purpose of conducting a manual audit of the tabulation system.

PURSUANT TO Section FS 101.6104 If any elector present for the canvass of votes believes that any ballot is illegal due to any defect apparent on the voter's certificate, the elector may, at any time before the ballot is removed from the envelope, file with the canvassing board a protest against the canvass of such ballot specifying the reason he or she believes the ballot to be illegal. No challenge based upon any defect on the voter's certificate shall be accepted after the ballot has been removed from the return mailing envelope.

PURSUANT TO Section FS 101.6103 (6) The Franklin County Canvassing Board will convene at 10:30 AM on Thursday, November 10th, 2016 at the Supervisor of Elections Office to conduct the manual verification of election results, precinct by precinct of all modem data compared to tabulation tapes. FS 101.015 (b) Canvassing Board will process Provisional Ballots FS 102.141 (5) and Certify Official Results to Department of State. FS 102.141 (5)

PURSUANT TO Section FS 102.141(7) and Rule 1S-2.031 Conditional Notice Official Recount. When a Recount is ordered by the Secretary of State, the Franklin County Canvassing Board will convene to conduct a Recount as required by law. Board majority required.

The Canvassing Board may reconvene if necessary for the 2016 General Election. The time and date will be posted at the Supervisor of Elections Office, the Franklin County Courthouse, the Franklin County Courthouse Annex, Carrabelle, Florida, the Apalachicola Post Office, and the Eastpoint Post Office. If meeting dates are known, these meetings will also be announced at the public Canvassing Board meetings.
